All items must be placed inside designated vendor spaces. Items are not permitted outside designated spaces, in walkways or in adjacent vendor spaces. Two chairs per registration provided. Additional spaces may be rented at regular prices. Requests are not guaranteed and are granted on a first-come first-serve basis. Confirmations of special requests are the responsibility of each individual vendor. Reservations must be completed no later than the Wednesday before the event. All spaces will be charted and reserved without change the Thursday before the event. All payments must be made at time of registration. The Seven Oaks Park Garage Sale is intended for the sale of second-hand household-type items only. The sale of animals, prepared food, local hand-made crafts or commercial wholesale items is not permitted at this event. The solicitation of funds or donations; the advertisement of businesses, agencies or organizations; and the display of logos, brands, names or campaigns are not permitted. Seven Oaks Park reserves the right to refuse sale of items based on event intent, appropriateness and in good taste with ICRC standards. Please do not leave children under the age of 16 unsupervised during the event. Set-up is available for vendors from 4:00-8:00 PM on Friday. Doors open to vendors at 6:30 AM Saturday. Gym side doors will remain open Saturday morning until 6:50 AM. Gym side doors will be locked at 6:50 AM and remain locked with alarm set for the duration of the event until 11:00 AM. Vendors are asked to use the front door after 6:50 AM. Doors will open to the public at 7:00 AM. No vendor set-up is permitted after 7:00 am for safety and aesthetic reasons. Event ends at 11:00 AM. All vendors must clear the gym by 12:00 PM. Refunds incur a \$5.00 processing fee. No refunds are offered after the Thursday before the event. Seven Oaks Park is not responsible for lost, stolen or damaged items; sale of items; handling of monies or making change; or personal liability during this event. All vendors are responsible for the removal of all trash and unsold items. Solicitation of any kind is not permitted at this event or at any time on any ICRC property without prior approval.
