1. Site Conditions

All roadways and parking spaces.

2. Restriping and Markings

A. All striping of lines and any other marking on pavement will be re-applied unless otherwise directed by owner throughout Saluda Shoals Park roadways and parking spaces.

- B. Paint will be applied by approved commercial striping equipment at the manufacturers' suggested application rate.
- C. All paints used will meet or exceed Federal Specification TTP115E or TTP1952BD. Prime oil spots. Heat and scrape excess oil off pavement and apply applicable Oil Spot Primer to promote adhesion of sealer.

3. Protection

- A. All barricades will be supplied and set up prior to commencement of work and removed from job site after completion of project.
- B. Owner will be responsible for having parking area cleared of vehicles.

2.0 Indemnification

Sec. 2001 et seq.; the Comprehensive Environmental Response Compensation and Liability Act of 2080, 42 U.S.C. Sec. 9601 et seq.; or the Hazardous Waste Cleanup-Model Toxics Control Act, RCW 70.105D, all as amended and subject to all regulations promulgated there under.
